Once a designation is identified as non-compliant, United Way of Metropolitan Dallas will notify the donor by email or letter that a donation designation may not be processed. If the donor does not respond within three weeks, that donation will be treated as undesignated.

Important tax information: Gifts made to United Way are tax deductible within the limits of current law. Please keep your copy of this pledge form along with your year-end pay stub for payroll deduction gifts or cancelled check for gifts under \$250. It will serve as a record of your donation to meet IRS regulations. One-time gifts over \$250 received by December 31, 2018, will receive a receipt from United Way.
